Tax rates The tax rate is 25.5%. For a company with capital of ¥100 million or less, a lower rate of 15% is applied to an annual income of ¥8 million or less. However, in the business years starting during the period from April 1, 2012 to March 31, 2015, an additional 10% tax will be imposed as Special Reconstruction Corporation Tax.
